


### **RELATIVE INTENSITY vs. WAVELENGTH**





# **SPATIAL DISTRIBUTION**












# **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**




### Notes

- 1. Don't cause stress to the LEDs while it is exposed to high temperature.


  2. The maximum number of reflow soldering passes is 2 times.

### TAPE SPECIFICATIONS (units: mm)




# **REEL DIMENSION** (units: mm)
