






RECOMMENDED SOLDERING PATTERN











Luminous Intensity vs. Forward Current 10.0 Luminous intensity normalised at 8.0






Forward Current Derating Curve






REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS






