





#### MINIMUM NOISE FIGURE, ASSOCIATED GAIN vs. DRAIN CURRENT




#### MINIMUM NOISE FIGURE, ASSOCIATED GAIN vs. FREQUENCY






#### Gate to Source Voltage Vgs (V)

#### MINIMUM NOISE FIGURE, ASSOCIATED GAIN vs. FREQUENCY






