1. General description

The 74AHC2G00; 74AHCT2G00 are high-speed Si-gate CMOS devices. They provide two 2-input NAND gates.

The AHC device has CMOS input switching levels and supply voltage range 2 V to 5.5 V.

The AHCT device has TTL input switching levels and supply voltage range 4.5 V to 5.5 V.






Fig 4. Pin configuration SOT505-2 (TSSOP8) and SOT765-1 (VSSOP8)




Fig 5. Pin configuration SOT996-2 (XSON8)









Fig 8. Package outline SOT505-2 (TSSOP8)




Fig 9. Package outline SOT765-1 (VSSOP8)




Fig 10. Package outline SOT996-2 (XSON8)
